Partnering to Increase Access to SUD Treatment

In Kansas, drug deaths attributed to synthetic opioids, predominantly fentanyl, more than doubled between 2019 - 2020, and 2020 - 2021. Of the 678 Kansas residents who died due to drug overdose in 2021, 63 percent involved an opioid, 51 percent involved a synthetic opioid, and 41 percent involved a non-cocaine psychostimulant.
