

# SUNRx Company Description for Kansas Hospital Association

As of November 2023



KHSC, along with Associated Purchasing Services, has entered into an agreement with SUNRx to assist 340B-eligible hospitals establish and operate a 340B contract and in-house pharmacy arrangements through consulting, processes and servicing. SUNRx will support hospitals in evaluating, planning, and implementing a 340B program for their entity.

Eligible 340B hospitals include non-profit Critical Access Hospitals, as well as Regional Referral Centers and Sole Community Hospitals with Disproportionate Share Hospital levels above a certain threshold. Eligible hospitals must register with HRSA's Office of Pharmacy Affairs. The registration website is located at: <https://www.hrsa.gov/opa/registration>.
