House Budget Committees Meet

Yesterday, the House Social Services Budget Committee, chaired by Rep. Les Mason (R-McPherson), heard budgets for the following:

- Kansas Guardianship Program
- Kansas Health Care Stabilization Fund

The committee also held an information briefing regarding the interim committee recommendations for Nursing Facility Reimbursement Rates.

The House Committee on Transportation and Public Safety Budget, chaired by Representative Avery Anderson (R-Newton), heard budgets for the following:

- Emergency Medical Services Board
- Office of the State Fire Marshal

The committees will make budget recommendations on these budgets in the coming days and then those will go to the House Appropriations Committee.

Senate Public Health and Welfare Receives Updates on Foster Care in Kansas

Today, the Senate Public Health and Welfare Committee, chaired by Sen. Beverly Gossage (R-Eudora), received an update from Kansas Department for Aging and Disability Services Secretary Laura Howard about foster care in the state. The committee will meet again tomorrow, Jan. 31 for a hearing on Senate Bill 363, amending statutes regulating the practice of barbering regarding licensure, examination and fees.

House Committees Hold Hearings on Several Health-Related Bills

Today, the House Federal and State Affairs Committee, chaired by Rep. Will Carpenter (R-El Dorado), held a hearing on House Bill 2358. This legislation allows mid-level practitioners to provide medical certification to attest to an individual's cause of death and to file a death certificate. The committee discussed a balloon amendment to the bill. The committee heard from the following:

The committee expressed an interest in amending the bill to include the ability for advanced practice registered nurses and physician assistants to be able to refer to hospice care. The chair indicated the bill will likely be worked Tuesday, Feb. 6.

The House Appropriations Committee, chaired by Rep. Troy Waymaster (R-Bunker Hill), held a hearing on Senate Bill 307, SB 307 adds for-profit private entity to the definition of "qualified applicant" in the Kansas Fights Addiction Act. The bill, carried over from 2023, when it passed the Senate on a vote of 40-0, had the following proponents in the House Appropriations Committee:

<u>House Bill 2547</u> authorizes schools to maintain certain emergency medication kits and to administer such medication in emergencies.

Senate Judiciary Committee Hears Updates on Funding for Local Corrections

Today, the Senate Judiciary Committee, chaired by Senator Kellie Warren (R-Leawood), received an update on last session's bill <u>Senate Bill 228</u>. SB 228 requires the Secretary for the Kansas Department for Aging and Disability Services to reimburse counties for costs when a person in a county jail awaits examination, evaluation or treatment for competency. The committee heard from Ed Klumpp, legislative liaison, Kansas Sherriff's Association, Kansas Association of Chiefs of Police and Kansas Peace Officers Association. Klumpp highlighted major changes including:

- Medical examinations before entering jail: they continue to train officers in this area. He
 discussed that medical leadership and law enforcement continue to work to improve
 best practices for information sharing.
- Reimbursement to cities and counties for holding inmates who are awaiting competency evaluations and treatments was discussed. Klumpp highlighted that \$4.3 million was reimbursed since July 1, 2023, and \$1.872 million this year. He also emphasized these costs go away if the state fixes the bed-space problems.
- In jail evaluations were highlighted as a process improvement but utilization rates have not been high at this point.
- Klumpp highlighted wait times for evaluations have gone down but wait times for treatment continue to be long. He shared that if there were no new additions to the wait lists as of today, the wait lists for services would be 11-12 months long.
- An example in Wichita jail was shared with a current inmate who has waited more than two years through the evaluation and treatment process.
