**House Social Services Budget Committee Hears from KDADS**

Yesterday, the House Social Services Budget Committee, chaired by Rep. Les Mason (R-McPherson), heard about agency budgets including those of the Kansas Department for Aging and Disability Services. The committee received an overview from the Kansas Legislative Research Staff and Deputy Secretary Scott Brunner of KDADS. The committee heard a budget overview of the mental health hospitals. Brunner highlighted Hospital programs, turnover and vacancy rates, admissions and wait lists. You can [view the presentation here](#).

The committee also approved the budgets for the Kansas Health Care Stabilization Fund and the Kansas Guardianship Program as recommended by the governor's budget. The committee will continue working budgets throughout the week.

**Senate Public Health and Welfare Committee Hears Barbering Bill**

Today, the Senate Public Health and Welfare Committee held a hearing on [Senate Bill 363](#). The legislation amends statutes regulating the practice of barbering regarding licensure, examination and fees. Committee members inquired as to the increased emails asking for a hearing on Medicaid expansion. The chair indicated she understands that a hearing will occur in some committees.

The committee meets again on Thursday for a hearing on [Senate Bill 103](#), updating certain provisions of the Kansas Dental Practices Act relating to dentist information requested by patients, in-person practice requirements in dental offices using the licensee's name; unprofessional conduct and patient complaints.

**House Appropriations Hears Updates on Community and Technical Colleges**

Today, the House Appropriations Committee, chaired by Rep. Troy Waymaster (R-Bunker Hill), heard an update from State Community and Technical Colleges. Heather Morgan, executive director of the Kansas Association of Community Colleges, highlighted that enrollments have increased by 10,000 students in training, nursing programs and the CNA training but not staying for LPN training. ### **House Health and Human Services Hears EMS Related Bill**

Today, the House Health and Human Services Committee, chaired by Rep. Brenda Landwehr (R-Wichita), held a hearing on [House Bill 2579](#). The legislation authorizes the Kansas Board of Emergency Medical Services to distribute non-prescription over-the-counter medications. The committee heard from the following:

Opponents:

The committee amended the bill to remove outdated language. The committee recommended the bill favorably as amended.

The committee also worked [House Bill 2578](#). The committee held lengthy discussions about who should be allowed to access the Certified Community Behavioral Health Clinic licensure with federally qualified health centers seeking the ability also to be deemed a CCBHC in the future. The bill was recommended favorably for passage as amended.

### **Child Welfare Committee Hears Bill About Medical Treatment**

Today, the Child Welfare Committee, chaired by Rep. Susan Concannon (R-Beloit), held a hearing on [House Bill 2580](#). The legislation would include mental, emotional and behavioral health treatment to medical services that may be provided to a child alleged or adjudicated to be a child in need of care.

### **House Corrections and Juvenile Justice Committee Works Bill**

Today, the Committee of Corrections and Juvenile Justice worked [House Bill 2487](#). The legislation provides immunity from prosecution for certain drug crimes when persons seek or provide medical assistance related to the use of a controlled substance with committee amendments.
