

# KHA's Current Report April 28, 2023

## President's Perspective – KHA Members Advocate on Capitol Hill

Congress is midway in its spring session. On Tuesday, a group of Kansas Hospital Association hospital executives met with members of the Kansas Congressional Delegation in their offices on Capitol Hill. We highlighted and advocated issues facing Kansas hospitals, specifically financial and workforce challenges. These visits bookended the 2023 American Hospital Association's Annual Membership Meeting, and they could not have come at a better time for discussing federal policies that affect providers nationwide and in Kansas.



Tuesday morning's AHA plenary session began with attendees listening to a presentation by a figure familiar to Kansans: Senator Roger Marshall, MD. He spoke about the challenges facing hospitals when it comes to prior authorization, particularly when it comes to treating patients on Medicaid Advantage plans. Senator Marshall has introduced two bills to address these matters, one that would streamline the prior authorization process and the other that would require more transparency for consumers considering switching to Medicare Advantage plans.

The Kansas group's first meeting on the Hill was with Senator Marshall and we got the opportunity to express our thanks to him for doggedly pursuing these issues.





In the afternoon, our focus shifted to the House of Representatives where there are troubling signs the fight over the debt ceiling and the budget may lead to calls for site-neutral Medicare payments. We discussed this concern with Congresswoman Sharice Davids and Congressman Tracey Mann, as well as with staff for Congressman Ron Estes and Congressman Jake LaTurner. On Wednesday, a House Energy and Commerce subcommittee had a hearing on site-neutral payments. Although none of our members are on the relevant subcommittee, they all understood how devastating this would be to patients' health, doctor/patient relationships and hospital finances. We also discussed workforce issues—particularly the nationwide nursing shortage—and our push for amendments to the Rural Emergency Hospital program that would make it more attractive for hospitals to join.

Later in the evening, we had the opportunity to meet with Senator Moran. As an appropriator, he is interested in helping to add the Bachelor of Science in Nursing to U.S. Department of Homeland Security's STEM certified degree list so foreign graduates of American BSN programs can receive student visa extensions with work authorizations while their prospective employers apply for their transitions to work visas. In general, our group also made sure to bring to every Kansas Congressional member's attention the fact that without a statutory waiver extension by the end of the fiscal year on Sept. 30, the Affordable Care Act's original disproportionate share hospital cuts will go into effect. These cuts are already in effect for the 40 states that have expanded Medicaid, but if they go into effect for the other 10—including Kansas—that have not expanded Medicaid, the result could be devastating to hospitals that provide care to the most vulnerable Americans. The most likely vehicle for an extension would be an end-of-year budget bill or continuing resolution. We will continue to work with the Kansas Congressional Delegation on this as we move into summer.

All in all, our time in DC was productive. Although it can seem that political gridlock is the norm, we are confident that our delegation understands our issues and continues to step forward to help. ## **Medicaid Unwinding Update**

For Medicaid beneficiaries who were in the first round of redeterminations for April 2023, who did not return their applications by the due date, they received a discontinuation letter last week with a termination date of May 1, 2023. The Medicaid call center has been inundated with phone calls and beneficiaries have experienced long wait delays. If KHA members receive questions from beneficiaries, please inform beneficiaries that they should still return their Medicaid application as soon as possible. Although termination will occur in the system on May 1, 2023, if the application is received within 90 days of the termination date and the application is approved, their eligibility will be turned back on and backdated to their termination date.

Please make sure beneficiaries know that the application must be received by KanCare by the date in the redetermination letter, not just postmarked by the date.

## Funding Opportunity: RCORP-Child and Adolescent Behavioral Health Program

The Health Resources and Services Administration Rural Communities Opioid Response Program is a multi-year initiative aimed at reducing the morbidity and mortality of substance use disorder, including opioid use disorder, in high-risk rural communities. This funding opportunity is under the RCORP-Child and Adolescent Behavioral Health program, which intends to establish and expand sustainable behavioral health care services for children and adolescents ages five-17 years who live in rural communities, and to prevent substance misuse. Over the four-year grant period, awardees are required to use the RCORP-CABH funding to achieve three program goals through a consortium-based approach:

Goal 1: Service Delivery - Establish new behavioral health prevention, treatment, and recovery services for children and adolescents aged five-17 years in the target rural service area.

Goal 2: Training and Peer Mentorship - Improve the capacity of rural health care providers, paraprofessionals, non-clinical staff, and community members to care for and support children and adolescents aged five-17 with behavioral health needs.

Goal 3: Community Partnerships - Build community partnerships to ensure children, adolescents, and their families, have access to community resources and human services that support the prevention, treatment and recovery from behavioral health disorders.

Eligible applicants include all domestic public or private, non-profit, and for-profit entities. Tribes and tribal organizations are eligible. The estimated total funding is \$9 million; with a \$1 million award ceiling. For a recording of the technical assistance webinar on applying for this grant, email ruralopioidresponse@hrsa.gov.

#### **CMS Releases New Hospital Price Transparency Enforcement Rules**

The Centers for Medicare & Medicaid Services is strengthening enforcement of its hospital transparency rule by imposing stricter timelines and levying fines more quickly. CMS is taking a firmer hand and eliminating flexibilities intended to promote compliance. Hospitals that fail to provide corrective action plans or remain out of compliance for more than 90 days after submitting such plans will automatically receive civil monetary penalties. Hospitals will have a maximum of 90 days to come into compliance after CMS agrees to the corrective action plan. CMS will no longer be offering warning notices to facilities that fail to come into compliance. CMS has increased the penalty for a full calendar year of noncompliance to a minimum of \$109,500 and a maximum of \$2 million per hospital. # Federal and National News CMS Updates IQR, IPFQR CART

The Centers for Medicare & Medicaid Services released updated CMS Abstraction and Reporting Tools for the Inpatient Quality Reporting and Inpatient Psychiatric Facility Quality Reporting programs.

- Inpatient 4.30.1 supports the IQR master code list diagnosis updates and must be used for discharges from April 1 to June 30, 2023. Installation instructions and other resources are available on QualityNet.
- IPFQR version 2.3.0 includes updates to support the calendar year 2023 abstractions.
   Version 2.3.0 must be used for discharges and events occurring Jan. 1 through Dec. 31, 2023. IPFs are required to report IMM-2 measure data based on discharges from Oct. 1, 2022, through March 31, 2023, during the summer 2023 submission. Therefore, CART IPFQR 2.3.0 must be used to abstract Q1 2023 IMM-2 measure data. Installation and resources are available on QualityNet.

## **CDC Simplifies COVID-19 Vaccine Recommendations Following FDA Authorizations**

The Centers for Disease Control and Prevention simplified <u>recommendations</u> for COVID-19 vaccination following the Food and Drug Administration <u>authorizing</u> changes to the emergency use Authorizatons of mRNA COVID-19 vaccines.

- Monovalent COVID-19 mRNA vaccines no longer are recommended for use in the U.S.
- Adults age 65 and older, as well as those who are moderately or severely immunocompromised, may receive an additional bivalent dose. Health care providers have the flexibility to administer additional bivalent doses to immunocompromised individuals as needed.
- All individuals age six and older should receive one bivalent dose, regardless of the primary series they received. These individuals do not need an additional bivalent dose unless they are over age 65 or are immunocompromised.
- For children under age six, multiple doses continue to be recommended but vary by age and vaccine type (manufacturer and mono/bivalent) that previously was received. However, all should have at least one bivalent dose.

It is anticipated that the CDC's <u>Interim Clinical Considerations</u> soon will be updated to provide additional information.

## **MACPAC Explores Medicaid Experience and Satisfaction Disparities**

Medicaid and Children's Health Insurance Program Payment and Access Commission <u>published</u> a <u>report</u> of the experiences and satisfaction of Medicaid-covered adults by race and ethnicity using data from the 2016-2022 Association of American Medical Colleges Consumer Surveys of Health Care Access. The study finds that 68.1 percent of individuals report having a usual source of care, and more than 80 percent report being able to get care when they needed it, being satisfied with the care they received and having positive experiences with their provider. However, persons of color were more likely to receive care at a clinic, health center or hospital emergency room, and were more likely to report experiencing unfair treatment and discrimination during their most recent medical visit.
