President's Perspective – KHA Unveils All Payer Scorecard

Kansas hospitals and health systems continue to face intense operational pressure while dealing with rising expenses for supplies, drugs and equipment, as well as the health care workforce. Increasing challenges relating to reimbursement and regulations with government and private commercial insurance payers over the past several years add to this pressure. The relationships between health care providers and insurance payers are growing strained as health care providers balance providing quality, accessible health care at a fair reimbursement.

An American Hospital Association survey published in November 2022 showed that 75 percent of hospitals have seen their relationship with insurance payers worsen. Ninety-five percent of hospitals are dedicating more staff resources to prior authorization and denial management requests.

In early 2022, the Kansas Hospital Association started reviewing options for an All Payers Scorecard. Many hospitals have lacked critical data to benchmark and measure themselves on payer issues such as prompt pay, denials, and clean claim rates. Understanding the need for this information, KHA established a membership committee comprised of hospital reimbursement and finance leaders to evaluate the different solutions available to assist hospitals. In the end, the KHA membership committee recommended the AHA Vitality Index Program. The AHA Vitality Index helps hospitals, health care systems, and state hospital associations understand the current payer environment and the impact it is having on Kansas hospitals and health care systems. It also provides insight into the practice habits of the public and private insurance carriers operating within the state. On a statewide level, the information collected can be used to aid in state policy and advocacy issues. With the scorecard, hospitals and health systems will now be able to identify which payers have prompt pay and denial issues, compare how other health care providers fair with the same insurance payers, and identify which insurers have claims processing challenges.

With the complete picture of the environment, hospitals will be able to help identify internal process improvements such as recurring coding errors and documentation inefficiencies. It also will highlight medical necessity denials with payers, and ultimately open the door to better communication with the payer industry.

The Kansas Hospital Association is committed to utilizing the data on your behalf by connecting with payers and sharing the data results with policymakers and state officials. Together we are a stronger organization and a stronger voice for change. We encourage you to take advantage of this opportunity to collaborate and share resources. KDHE Issues Alert Regarding Anti-Tuberculosis Drug Shortage

On May 10, The Kansas Department of Health and Environment issued a KS-HAN alert regarding the shortage of the anti-tuberculosis medication rifampin, which has been classified by the Food and Drug Administration as in short supply since December 2021. The Kansas Department of Health and Environment TB Control Program has a limited supply of rifampin on hand and is prioritizing shipment of rifampin for active TB disease patients. Cancer Drug Shortages Impact Patients and Hospital Care

Drug shortages continue to impact patients and hospital care, with shortages of cancer drugs causing growing concern. According to a <u>March 2023 Homeland Security report</u>, drug shortages increased nearly 30 percent between 2021 and 2022; with more than 15 critical drug products in shortage for more than the last ten years. The Food and Drug Administration issued <u>draft guidance</u> in April to manufacturers regarding notifying the FDA on discontinuance or interruption of manufacturing; intended to assist FDA with prevention and mitigation of drug shortages. There are a number of cancer drugs and other critical agents on the <u>ASHP drug shortage list</u>.

KHA staff continue to monitor drug shortages and stay in contact with the American Hospital Association, FDA and Region VII federal agencies regarding drug shortages. According to recent communications with the FDA, methotrexate injection, cisplatin injection, and carboplatin injection shortages have occurred due to the decision of one manufacturer to place product on hold and the remaining approved manufacturers have had difficulty meeting demand.

The FDA is continuing to work with approved manufacturers on resolving these shortages and are exploring all options, including temporary importation. Providers may also continue to report drug shortages to the FDA and request assistance on obtaining supply by contacting <u>Drugshortages@fda.hhs.gov</u>. KHA wants to hear from our members about how drug shortages are impacting your patients and facility so that we may continue to keep this issue at the forefront with AHA and federal agencies. Federal and National News

FDA Approves RSV Vaccine for Adults Age 60 and Older

The Food and Drug Administration on May 3 <u>announced</u> its approval of <u>Arexvy</u>, the first respiratory syncytial virus vaccine approved for use in the United States. Arexvy, a GlaxoSmithKline product, is approved for the prevention of lower respiratory tract disease caused by RSV in individuals 60 years of age and older. In June 2023, the CDC's Advisory Committee on Immunization Practices will make recommendations on the appropriate use of the vaccine. The vaccine will be available for older adults before the 2023/24 RSV season, which typically starts ahead of the winter months. Pfizer, Moderna and J & J all have RSV vaccine candidates in late-stage development.

USPSTF Issues Draft Recommendation for Breast Cancer Screening to Begin Starting at Age 40

The U.S. Preventive Services Task Force issued a <u>draft recommendation</u> on May 9 urging all women to be screened for breast cancer every other year, starting at age 40. For the current draft recommendation, the USPSTF recommends biennial screening mammography for women ages 40 to 74 years. When final, this recommendation will update the 2016 recommendation on breast cancer screening.

HHS Extends Certain PREP Act Protections Beyond PHE

The Department of Health and Human Services May 11 <u>amended</u> its Public Readiness and Emergency Preparedness Act declaration for COVID-19 to extend liability protections for certain COVID-19 countermeasure activities beyond the May 11 end of the public health emergency. Under the amendment, <u>planned</u> since April, PREP Act liability immunity will apply through 2024 to all COVID-19 medical countermeasure activities provided through a federal agreement; and to pharmacists, pharmacy interns and pharmacy technicians who administer COVID-19 and seasonal flu vaccines and COVID-19 tests, regardless of a federal agreement or emergency declaration, among other changes.

HRSA Introduces Updated Maternal Mental Health Hotline

HHS and HRSA celebrated the <u>first anniversary</u> of the National Maternal Mental Health Hotline, which provides 24/7, free and confidential emotional support, resources and referrals to pregnant and postpartum people facing mental health challenges.

HRSA now is introducing an updated toll-free number for the hotline: 1-833-TLC-MAMA (1-833-852-6262). The former number (1-833-9-HELP-4-MOMS or 1-833-943-5746) will remain active for another year. Please share the hotline information with your communities.

CDC Issues Health Update on Potential Risk for New Mpox Cases

The Centers for Disease Control and Prevention issued a <u>health update</u> on the potential risk for new mpox (formerly monkeypox) cases. Cases have declined since peaking in August 2022, but the CDC continues to receive reports of cases and ongoing transmission. From late April to early May, 12 confirmed cases and one probable case of mpox were reported in Chicago.
