The Kansas Hospital Association's <u>Health Care Worker of the Year Award</u> highlights hospital employees who have made a significant contribution to the betterment of their hospital. These individuals are nominated for this award because they routinely go above and beyond the call of duty.

At her core, Adrienne White knew she loved helping people with their basic needs. She first realized it when she was a leasing agent, but then wanted to do more. So, she became a nurse. White began her career at Ascension Via Christi St. Teresa, Wichita, as a medical-surgical nurse on the night shift. Next, she extended her help to the hospital's intensive care unit and emergency department. Eventually, she was named unit charge nurse before becoming the house charge nurse. When St. Teresa implemented a house supervisor role 18 months ago, she was asked to lead this new role. In total, White has served in a leadership position for seven years.

White has been at St. Teresa for 13 years, starting from the day the hospital opened. She is very kind and compassionate to her patients, always going the extra mile to accommodate and make them smile. In her current role, White oversees multiple units and staff members. She is a natural leader, fair and personable. She values her position because it allows her to assist teammates across different units, helps to lead teams through high-pressure situations and teaches nurses by empowering their curiosity instead of giving them the answer. When time allows, she still takes time to sit and talk with patients. White has an impressive talent for listening to patients and enjoys finding solutions so they feel heard. Whitney Winder is dedicated to providing outstanding and equitable patient care. As a registered nurse with Smith County Memorial Hospital in Smith Center, Winder epitomizes compassionate care and teamwork.

Smith County Memorial Hospital is located in a maternity desert, so Winder seeks educational opportunities to improve her skills to maintain obstetrics labor and delivery services. Her passion for serving lower socio-economic families fuels her tenacious pursuit of national and regional grants. She recently coordinated a team of three nurses, including herself, to complete a three-day training with Drive Safe Kansas to become certified as child passenger safety technicians.

Winder works to achieve health equity using evidence-based infant nutrition practices. Her commitment to helping underserved babies thrive in their homes led her to implement the EMPower Best Practices at SCMH as part of the Baby-Friendly Hospital Initiative. Thanks to her work to receive a national grant, the EMPower educational resource is now available to the nursing staff. Winder also shares her knowledge by teaching the EMPower Best Practices to every nurse in Smith County, as well as leading regional educational training on infant nutrition.

Winder is empathetic and understanding of the needs of new parents and families. She became a certified lactation educator to offer breastfeeding support to new parents. Educating parents is her passion because she believes it helps parents succeed while alleviating stress. She also teaches childbirth and baby basics classes in the community four times a year and includes time in the courses for parents to ask questions and get to know other families in the area.

#### **Federal and National News**

#### HHS Releases List of Selected Medicare Part D Discounted Drugs

Congress enacted the Inflation Reduction Act of 2022, which <u>provides</u> Medicare the ability to negotiate prices for certain high-expenditure, single-source drugs that do not have generic or biosimilar competition. Because of the Act, the U.S. Department of Health and Human Services <u>released</u> a list of 10 drugs covered under <u>Medicare Part D</u> for 2026.

#### TJC Releases Specifications Manual Version 2024A

The Specifications Manual for Joint Commission National Quality Measures, Versions 2024A, effective for discharges Jan. 1 to June 30, 2024, has been posted to <u>The Joint Commission</u> <u>website</u>. Changes are outlined in the associated release notes.

#### CMS Review and Correction Period Open for FY 2024 HAC Reduction Program HSRs

The Centers for Medicare & Medicaid Services released the fiscal year 2024 Hospital-Acquired Condition Reduction Program Hospital-Specific Reports via the <u>Hospital Quality Reporting</u> <u>system</u>. The review and correction period now is open and ends Thursday, Sept. 28. <u>Additional information</u> is available.

# CDC Issues Health Update on Locally Acquired Malaria Cases

The Centers for Disease Control and Prevention issued a Health Alert Network Health Update to share new information about locally acquired malaria cases. These are the first confirmed malaria cases acquired locally in the U.S. since 2003. Clinicians may consider a malaria diagnosis in any person with an unexplained cause of fever. Cases now have been <u>identified</u> in three states. For additional information on malaria diagnosis and treatment, a <u>CDC COCA call</u> recording is available.

### **HRSA Requires 340B Recertification**

The Health Resources & Services Administration Office of Pharmacy Affairs requires registration and approval for covered entities to participate in the 340B Drug Pricing Program. The annual recertification period for 2023 is open until Monday, Sept. 11. To recertify, authorizing officials and primary contacts must set up a user account in the <u>340B OPAIS</u>. Educational resources and frequently asked questions are available on the <u>HRSA OPA website</u>.

### CMS Identifies Calculation Errors of OQR Program Measures Displayed on Care Compare

The Centers for Medicare & Medicaid Services identified errors in the calculation of thirdquarter 2022 data displayed on Care Compare for two measures in the Hospital Outpatient Quality Reporting Program.

- OP-18b: Median time from emergency department arrival to emergency department departure for discharged patients excludes psychiatric/mental health patients
- OP-18c: Median time from emergency department arrival to emergency department departure for discharged patients only psychiatric/mental health patients

The corrected third-quarter 2022 OP-18b and OP-18c data are available within the July 2023 Preview Report in the <u>Hospital Quality Reporting system</u>. Providers are encouraged to review the corrected data during the 30-day preview period, which ends Thursday, Sept. 21. The corrected data will be published to Care Compare immediately following the 30-day preview period.

- Through the National Health Service Corps Students to Service Loan Repayment Program, medical, nursing or dental school students may qualify for as much as \$120,000 in tax-free loan repayment in exchange for a three-year service commitment in a high-need rural, tribal or urban community. <u>Applications</u> are due by Thursday, Dec. 7.
