President's Perspective – Kansas Legislative Session on the Horizon

This week, legislators from across the state started arriving in Topeka for the commencement of the 2024 Kansas legislative session. While the session doesn't officially start until Monday, Jan. 8, legislators are using this week to move into their living quarters and legislative offices. Heading into the session, there has been varied speculation on the legislative priorities that will be considered, and ultimately, adopted by the legislature and the governor. The Kansas Hospital Association has been preparing for the 2024 session for the past several months, working with the KHA membership and hosting legislative gatherings throughout the state. As always, the start of a new legislative session brings a mixture of excitement and uncertainty as to what issues will ultimately make their way through the legislative process.

The advocacy efforts by KHA are an important part of our advocacy strategy, but equally, if not more critical, is to have the KHA membership closely monitoring and engaging with their elected officials to share why key legislation is essential for serving your community's health care needs. KHA's legislative platform is developed with the input from the membership, guidance from the KHA policy committees and approval from the KHA Board of Directors. Many of the legislative priorities for 2024 fall into two buckets: financial viability and workforce. The legislative proposals being pursued around financial viability include raising the Medicaid reimbursement rates, streamlining prior authorization processes, investing in behavioral health resources and increasing health care coverage through Medicaid expansion. KHA will be pursuing an equivalent number of legislative policies to address the health care workforce needs in Kansas.

KHA members will have the opportunity to stay informed on legislative developments through our frequent *Capitol Comments* newsletter. We encourage the membership to share their perspectives as issues are discussed. KHA also will continue to utilize our grassroots tool, VoterVoice. This platform allows members to sign up for alerts, find legislation and connect with their elected officials via the web or cell phone. If you have not yet registered to receive these updates, you can go here to sign up.

One easy way for KHA members to become active in our state advocacy efforts is through participation in our annual KHA Advocacy Day. This year's event will be held on Tuesday, Jan. 16 and will include comments from several elected officials including Governor Laura Kelly, Secretary of State Scott Schwab, Senate President Ty Masterson and House Majority Leader Chris Croft. We also will be recognizing the inaugural KHA Advocacy All-Star graduates as they conclude their advocacy training. KHA Advocacy Day will conclude with a "grab-and-go" lunch at the Kansas Statehouse to allow hospital leaders to meet with their individual elected officials. Register today. ASPR Grant Funding for Hospital PPE Expenses

The Administration for Strategic Preparedness and Response COVID-19 Hospital Association Grant has funds still available for the grant period Apr. 9, 2023 - Feb. 28, 2024. Eligible grant expenses are limited to ASPR Funding Focus Area 2: Personal Protective Equipment Procurement and Optimization Measures. Grant funds may be used for the purchase of PPE, related supplies and equipment used to care for patients with, or suspected, to have COVID or other emerging respiratory pathogens. The grant funds are available through the Kansas Hospital Association on a first-come first-served basis until all the grant dollars are exhausted. Federal and National News

CMS Proposes Appeal Rights for Certain Changes in Patient Status

The Centers for Medicare & Medicaid Services <u>released</u> a proposed rule that would require HHS to establish appeals processes for certain Medicare beneficiaries who initially are admitted as hospital inpatients but subsequently are reclassified as outpatients receiving observation services. Specifically, the rule proposes standard, expedited and retrospective appeals processes. CMS states within the footnotes that "the appeals processes proposed in this rule do not extend to enrollees in Medicare Advantage plans." Comments are due Monday, Feb. 26.

CMS Finalizes CLIA Fees, Histocompatibility, Personnel and Alternative Sanctions for Certificate of Waiver Laboratories

The Centers for Medicare & Medicaid Services <u>released</u> a <u>final rule</u> that adjusts laboratory fees, revises certain requirements for both the histocompatibility tests specialty as well as personnel qualifications and responsibilities, and allows CMS to impose alternative sanctions against noncompliant Certificate of Waiver laboratories.

ACMT, AACT Release Statement on Nalmefene

The American College of Medical Toxicology and American Academy of Clinical Toxicology released a <u>joint opinion</u> advising that nalmefene should not replace naloxone as the primary opioid antidote. Nalmefene was approved for use via injection in 1995 but was removed from the market in 2008. In May 2023, the Food and Drug Administration approved it as an intranasal product. Because Nalmefene was approved for use in the past, new clinical studies were not completed before approval of this new product. Due to the lack of new data, Naloxone should continue to be utilized to treat known or suspected opioid overdose.

HRSA Announces Funding Opportunity for PCTE-PARB

The Health Resources and Services Administration released a new grant opportunity to increase the number of trained physician assistants practicing in rural areas after graduation. The Primary Care Training and Enhancement: Physician Assistant Rural Training in Behavioral Health Program aims to address the need to train primary care physician assistants to prevent, identify, diagnose, treat and refer services for behavioral health conditions. Applications are due Friday, March 15.
