President's Perspective - Rural Health Leaders Gather at AHA Leadership Forum

First of all, what a fun and exciting Super Bowl victory for the Kansas City Chiefs last Sunday night. For all of us long-time Chiefs fans, the past several years have been absolutely amazing! Let's try to run it back for a third time in a row next year!

This week, I had the opportunity to join health care leaders from across the country to discuss the current rural health care environment and the innovative solutions that are being explored by communities to ensure access to quality health care. Attendees of the American Hospital Association's Rural Health Care Leadership Forum heard from industry experts on topics that ranged from the impact of artificial intelligence on rural health care delivery, opportunities to recruit and retain a strong health care workforce, to building a culture of leadership. There were many practical and useful resources that were shared during the variety of presentations that could benefit many rural hospitals and communities.

Several breakout sessions focused on the use of AI to achieve efficiencies in the areas of administrative paperwork and revenue cycle management. I also was especially interested in learning how hospitals and health systems were combating the ever-growing number of cyberattacks by empowering their staff members to take immediate steps when an attack occurs as well as proactively developing regional cyber-security contingency plans across multiple hospitals. Towards that end, KHA is partnering with the American Hospital Association, Missouri Hospital Association and The University of Kansas Health System to offer a cyber-security education program on Tuesday, April 23. This event is open to all KHA members and interested individuals may register online.

Attendees also heard an update from AHA staff on federal advocacy initiatives being sought after on behalf of rural hospitals to address the challenges facing the industry. Legislation is being promoted to require commercial insurer accountability, support flexible payment options, ensure fair and adequate reimbursement, bolster the workforce and protect the 340B drug discount program. Among the advocacy priorities in the area of commercial insurer accountability is to require cost-based reimbursement for Critical Access Hospitals from Medicare Advantage Plans as well as building on recent regulations and legislation that further streamline and improve the prior authorization processes. KHA will continue to partner with AHA and the National Rural Health Association on federal advocacy policies to support and protect Kansas hospitals and the communities we serve.

I lastly want to thank the several current and former KHA members who attended as well as presented at the event. Presenters included recently appointed CEO Benjamin Anderson, Hutchinson Hospital and retired CEO Jeff Bowman, Southcentral Kansas Regional Medical Center. Benjamin discussed the need to build a culture of leadership and Jeff highlighted his experience in transitioning his community hospital into a rural emergency hospital. Other Kansas hospital and health care leaders who attended represented Holton Community Hospital, Anderson County Hospital, Allen County Regional Hospital, Community Memorial Healthcare, Hutchinson Regional Medical Center, LMH Health, Minneola Healthcare, Coffey County Hospital, Russell Regional Hospital, the Kansas Healthcare Collaborative and the University of Kansas School of Medicine. Kansas State Board of Healing Arts Licensure Update

The Kansas State Board of Healing Arts has provided an update on health care professional licensure and information that can impact licensing timelines as well as suggested best practices to avoid licensing delays. KSBHA is the executive body tasked with licensing and regulating 16 health care professions in Kansas, including physicians and physician assistants.

The Board is composed of 15 members, 12 of whom are licensed health care professionals from various professions, including eight licensed physicians. The length of time to obtain a license in Kansas varies depending on the time of year, the license type sought and the completeness of the application submitted, as well as other factors which may be personal to each applicant. In general, applicants should allow four to six weeks for an application for licensure to be processed. KSBHA notes that there may be some unique circumstances when a Kansas hospital hires an out-of-state physician to come to Kansas for employment. Occasionally, that physician may run into a delay in obtaining their Kansas license to practice for various reasons. KSBHA has

shared the following ways a hospital/facility, and the applicant, may be able to help prevent or alleviate some of those delays.

- 1. If the candidate is licensed in another state, determine if they might qualify for licensure via the Interstate Medical Licensure Compact. This is an expedited licensure process and can save weeks if your candidate qualifies. Information on the IMLC can be found here.
- 2. Determine through the interview process (interviews and resume/CV) whether your candidate is foreign trained and/or from an accredited program. Ensure they have the required number of approved hours of post-graduate training. If they graduated from a foreign medical school or an unaccredited program, try to determine if the program is substantially equivalent to an ACGME accredited program as this can cause licensure to take longer than expected.
- 3. Determine through the interview process (interviews) whether your candidate has anything in their background that may impact the licensure process. This could be any past professional misconduct/discipline of their license, any past legal issues (no matter how seemingly small), etc.
- 4. If your candidate is a new graduate, start the licensure process as early as possible and send final transcripts when they are available. Otherwise, ensure the application is complete when it is sent to avoid the Licensing Analyst from needing to contact the applicant for missing requirements. Ideally, do not set a work start date until licensure has been successfully accomplished. If you do set a date, be prepared for this date to be fluid.

If your candidate has any of these issues, you may wish to consider requesting they sign a third-party release of information form. This will allow the KSBHA staff to provide you with updates if the process is taking longer than expected. The release of information form can be found here (select "Third Party Release"). CMS Issues Revised Texting Guidance

CMS issued revised <u>guidance</u> on the texting of physician orders. The texting of patient information and patient orders among members of the health care team is permitted if accomplished through a HIPAA-compliant, secure texting platform and in compliance with the Conditions of Participation. MHA is evaluating the revised guidance and seeking clarification on certain requirements.

Maternal Syphilis Rate Triples Over Six Years

The CDC <u>reports</u> syphilis infections during pregnancy more than tripled between 2016 and 2022 to 280 cases per 100,000 births. In November, the CDC <u>reported</u> more than 3,700 mothers passed on the infection to their babies in 2022 — 10 times more than in 2012 — although timely testing and treatment could prevent most mothers from transmitting the infection to their babies.

The American Academy of Family Physicians recommends <u>screening</u> for all pregnant women. The CDC provided treatment <u>guidelines</u> for maternal and congenital syphilis.
