### **President's Perspective – AHA Hosts Regional Policy Board in Kansas City**

Last week, I had the opportunity to attend the American Hospital Association's Regional Policy Board meeting for Region Six in Kansas City. RPB Six includes Kansas, Iowa, Minnesota, Missouri, Nebraska, North Dakota and South Dakota. The hospital leaders from this region discussed many timely and significant issues confronting health care providers and hospitals across the country. As always, the AHA team did a fantastic job in preparing and facilitating the meeting agenda.

The meeting began with an update from AHA leadership on initiatives to enhance public trust and confidence. AHA has made a multi-faceted effort to preserve and enhance public perception of the value hospitals and health systems provide for their communities. The RPB members discussed the need to provide additional education and information to state and federal elected officials. In addition, a focus on sharing information with the media regarding patient stories and the challenges the insurance industry poses to hospitals nationwide was identified. Much of the work AHA is pursuing relates to the public perception campaign KHA is engaged in on the state level. If you missed last week's *President Perspective*, I encourage you to go back and read the work KHA is doing in this area.

The AHA team also provided an update on the latest advocacy efforts on the federal level, as well as the status of the Change Healthcare cyber-attack. AHA's priority issues include protecting hospital finances during the impending budget discussions, safeguarding the 340B Drug Discount Program and protecting health care workers from workplace violence through the SAFE Act. AHA's efforts would not be as successful if not for the thousands of hospitals, including those in Kansas, united in our advocacy efforts. We continue to encourage KHA members to join in our advocacy efforts and share personal stories regarding the effect public policies will have on your hospital and the patients you serve.

In addition to the advocacy update, the RPB meeting focused on several issues: 1) commercial health plan accountability; 2) impact of high-cost drugs and therapies; 3) engaging with employers on the local level; 4) current and emerging regulations of artificial intelligence and use in hospital and health systems; 5) hospital financial challenges; 6) AHA's strategic workforce initiatives; 7) unwinding the public health emergency; and 8) mitigating cybersecurity risks.

Kansas hospitals were well-represented at this week's RPB meeting by Melissa Atkins, Graham County Hospital, Hill City; Sherri Vaughn, MD, The University of Kansas Health System, Kansas City; and Larry Van Der Wege, Lindsborg Community Hospital, Lindsborg. Thanks to these hospital leaders for their representation of Kansas hospitals.

### **KHA Sends Letter to Delegates Urging Them to Help Hospitals Impacted by Change Healthcare Cyberattack**

On Mar. 14, The Kansas Hospital Association sent [letters](#) to the Kansas Congressional Delegation encouraging them to support statutory changes that can adequately help hospitals impacted by the Change Healthcare cyberattack. In the letter, KHA highlighted the following:

- Direction for Medicare Administrative Contracts to prioritize and expedite review and approval of hospital requests for sufficient Medicare advanced payments for hospitals experiencing payment delays.
- Issuing guidance to all payers outlining expectations that payers will implement periodic interim payments; waive timely-filing requirements, extend timelines for appeals and not deny claims due to lack of authorization.
- Use powers to ensure that UnitedHealth Group takes all necessary steps to remedy the situation, including implementing a meaningful financial assistance program.

### **CDC Issues Health Alert on Increasing Measles Cases**

This week, the Centers for Disease Control and Prevention issued a [health advisory](#) informing clinicians and public health officials of an increase in global and U.S. measles cases and to provide guidance on measles prevention for all international travelers ages more than six months and all children aged more than 12 months who do not plan to travel internationally. Measles is highly contagious. One person infected with measles can infect nine out of ten unvaccinated individuals with whom they come in close contact. From Jan. 1 to Mar. 14, 2024, the CDC has been notified of 58 confirmed U.S. cases of measles across 17 jurisdictions, including seven outbreaks in seven jurisdictions compared to 58 total cases and four outbreaks reported the entire year in 2023. Among the 58 cases reported in 2024, 54 (93 percent) were linked to international travel. Most cases reported in 2024 have been among children ages 12 months and older who had not received the measles-mumps-rubella vaccine. ### **USDA Loans and Grants to Broadband Services Open**

The Rural Utilities Service at the U.S. Department of Agriculture will begin accepting applications on Mar. 22 for the Reconnect Loan and Grant Program. The program provides loans and grants for constructing, improving or acquiring facilities and equipment needed for broadband service. Funding for qualified applicants, including Federally Recognized Tribes, varies depending on the percentage of households lacking sufficient access to broadband in a Proposed Funded Service Area.

## **PSU Sexual Assault Nurse Examiner Grant Program – Spring Classes**

The Pittsburg State University Sexual Assault Nurse Examiner Grant Program is offering many free training classes this spring. PSU and the Kansas Coalition for Sexual and Domestic Violence have collaborated in providing didactic courses free of registration fees. Registered nurses, advanced practice registered nurses, advocates and law enforcement can choose between the Adult/Adolescent course (SANE-A) or the new 64-hour Adult, Adolescent, Pediatric Course (SANE-A/-P). There are additional training options for rural organizations, such as the eight-hour evidence collection in the emergency room. Once the RN or APRN finishes the didactic portion, they will be assisted to find a preceptor to continue the clinical portion. The clinical courses are offered through KU Med quarterly. ### **CMS Announces ACO Primary Care Flex Model**

The Centers for Medicare & Medicaid Services Innovation Center [announced](#) a new payment model for primary care, the [Accountable Care Organizations Primary Care Flex Model](#). The model would be part of the Medicare Shared Savings Program and will [test](#) whether "improved payment for primary care will empower participating ACOs and their primary care providers to utilize more innovative, team-based, person-centered and proactive approaches to care and positively impact health outcomes, quality and cost of care." The ACO PC Flex Model application period opens May 2024, and the performance period begins Jan. 1, 2025.

## **Change Healthcare Cyberattack Updates Available – AHA Survey Results and Medicaid Advanced Payments**

The American Hospital Association [released](#) results from a survey to gauge the effect of the recent Change Healthcare cybersecurity breach. According to AHA, 74 percent of hospitals report direct patient care impact, nearly 40 percent report delays in processing health plan utilization requirements, 94 percent report financial impact and 82 percent report impact on cash flow.

The Centers for Medicare & Medicaid S issued [guidance](#) outlining processes for an expedited state plan amendment for states to advance fee-for-service payments for providers affected by the Change Healthcare attack. The guidance also highlights the existing authority state agencies have to limit managed care plans' restrictive prior authorization and network practices.

## **MedPAC Releases March 2024 Report to Congress**

The Medicare Payment Advisory Commission released a [report](#) to Congress that includes recommendations for fiscal year and calendar year 2024 Medicare payment rates. MedPAC commented that "given the worsened financial circumstances in 2022, and the approximately \$3 billion decline in existing Medicare disproportionate share hospital and uncompensated care payments from 2019 to 2024, the Commission contends that all hospitals – and in particular those serving large shares of low-income Medicare patients – warrant greater support than the Commission recommended last year. Thus, the Commission recommends that the Congress update the 2024 Medicare base rates for general ACHs by the amount reflected in current law plus 1.5 percent."

## **MACPAC Recommends More Transparency and Oversight of Medicaid Managed Care Denials**

The Medicaid and Children's Health Insurance Program Payment and Access Commission released the 2024 [report](#) to Congress. In addition to the required [analysis on DSH](#), the MACPAC report includes an [analysis](#) of Medicaid managed care denial and appeal processes and recommendations for improving transparency and state oversight.
