# President's Perspective – KHA Board Convenes in Topeka

The Kansas Hospital Association Board of Directors met earlier this week in Topeka to discuss several timely and important topics affecting the association and its membership, including the latest advocacy issues at the state and federal levels.

Today marks the official end of the regular portion of the 2025 Kansas legislative session. Legislators are heading back to their respective districts and will return to Topeka for the veto session, which is anticipated to start on April 10. This legislative break is an opportune time for KHA members to connect with Kansas House and Senate members to discuss the most important issues to you and your community.

The KHA Board had the opportunity to hear first-hand from one of our state leaders, Senate President Ty Masterson. Senator Masterson provided a brief overview of the ongoing legislative budget discussions and the financial outlook for the next few years. He recognized the importance of the health care industry and touched upon his support for Kansas hospitals, especially as it relates to protecting our workforce against acts of violence and addressing the behavioral health challenges within our state. Senator Masterson also highlighted the recent approval by the Kansas Senate on the 340B legislation and acknowledged that Kansas hospitals need to engage and educate House members on this issue.

The KHA team will discuss how best to engage our state and federal officials during our upcoming KHA district meetings, which begin next week. We hope you can take some time out of your schedule to attend a meeting and network with your colleagues!

## **Update Regarding Terrorism Threat to Hospitals**

Following up on the Kansas Hospital Association's email dated Friday, March 21, to CEOs and emergency preparedness contacts regarding the AHA and Health-ISAC Bulletin on a Threat to Hospitals, we have stayed in contact with state and federal partners. According to the Federal Bureau of Investigation, as of March 26, there are no specific credible threats against hospitals in any U.S. city. The Kansas Intelligence Fusion Center also shared Hospitals and Healthcare Facilities: Security Awareness for Soft Targets and Crowded Places and What to Do Bomb Threats as resources from the Cybersecurity and Infrastructure Security Agency for overall security preparations. Our recommendation, as well as that of the Kansas Intelligence Fusion Center, is to remain calm yet vigilant. Review emergency response plans and communications, and remind staff that if they see something, they should say something.

## Second Financial Awareness Campaign Release - New One-Page Resource on Medicare

The Kansas Hospital Association is working to tell the hospital finance story broadly this spring. KHA initiated these efforts with our annual campaign focused on the <u>economic impact of hospitals and the health care industry</u>. We then updated our financial infographic highlighting Kansas hospitals' overall financial challenges and recently created a one-pager on Medicaid. We hope these tools will help hospitals have meaningful conversations about financial challenges and implement positive changes.

This week, KHA is sharing with members the next area of focus for our <u>Financial Awareness</u> <u>Campaign: Medicare</u>. Our new one-page resource, available to help kick-start discussions about Medicare, explains how Medicare provides critical health coverage to various people in every community across Kansas. This coverage helps ensure that patients receive the necessary medical services to live healthier and more productive lives. It also projects Medicare cuts through 2030, and the number of Kansans on Medicare is expected to rise in the coming years.

We have a new toolkit link on Box.com that houses not only the print resources in this campaign but also template social media posts and other communications tools. KHA will boost messages on our social platforms to educate the public and policymakers about Medicare, explaining the program and highlighting its challenges. In a nutshell, supporting the Medicare program will enhance the financial viability of Kansas hospitals and ensure health care for an aging Kansas population.

# **Measles Cases Increasing in Kansas**

As of March 26, the number of measles cases in Kansas had increased to 23 across six counties, up from 10 cases in three counties on March 21. There are excellent measles and measles, mumps and rubella vaccination resources, including updates, symptoms and frequently asked questions for providers, clinical staff, parents and caregivers on the <a href="Immunization Kansas">Immunization Kansas</a>
<a href="Coalition Measles/MMR Vaccine Resource Hub">Coalition Measles/MMR Vaccine Resource Hub</a>. The <a href="Kansas Department of Health and Environment's Reportable Infections Disease Dashboard">Dashboard</a> provides up-to-date information on reportable infectious diseases, including measles cases. For facilities or providers wishing to further understand the potential risk of transmission in their communities, KDHE's <a href="Kindergarten Immunization Data Dashboard">Kindergarten Immunization Data Dashboard</a> shows vaccination rates at the state level and by school district, including for MMR. Many Kansas school districts are well below the recommended 95 percent MMR vaccination rate for herd immunity.

# Kansas Crisis Standards of Care Guidance for Long Term Care Facilities

The Kansas Department of Health and Environment Preparedness Program and the Bureau of Community Health Systems worked together with the Kansas Health Institute and other partners from around the state, including the Kansas Hospital Association and KHA member hospital representatives, to create the <u>Kansas Crisis Standards of Care Guidance for Long Term Care Facilities</u>. The guidance for LTC facilities follows the Kansas Crisis Standards of Care Guidance document, revised in 2023, which was originally created for hospitals.

This document aims to assist hospitals and long-term care facilities in planning for events that may require contingencies when dealing with a surge event with limited resources. --Larry Van Der Wege

# **AHA Report Discusses Impact of Medicare Advantage on Rural Hospitals**

As essential care providers and major local employers, rural hospitals are vital to the health and economic well-being of their communities. However, they face significant financial pressure that threatens their ability to provide essential services.

A contributing factor is the increasing number of Medicare-eligible Kansans who are covered by Medicare Advantage vs. traditional Medicare — 54 percent in April 2024, up from 30 percent in 2016, with the trend expected to increase.

MA plans often pay less than traditional Medicare for equivalent services, reduce payments through routine denials, implement overly burdensome appeals processes, unilaterally impose site-of-service limitations and restrict inpatient transfers. MA plans also use tactics that delay patient discharges by refusing to authorize appropriate post-discharge services.

The Kansas Hospital Association continues to <u>advocate for clear legislation</u> that compels MA plans to follow basic benefit coverage policies and to <u>help hospitals inform consumers about the</u> important differences between their coverage options.

- A recent <u>research report</u> published in the journal *Addiction* explores retention rates among patients with opioid use disorder prescribed 16, 24, 32 and 40 mg doses of buprenorphine-naloxone. Treatment retention rates were higher among those with a daily buprenorphine dose of 24 mg when compared to those on 16 mg.
