President's Perspective – Kansas Congressional Members Weigh in on Medicaid Policy

The past few weeks in Washington, DC, have been hectic to say the least. Kansas Hospital Association staff worked extensively with the Kansas House of Representatives delegation to seek certain changes and clarifications in the One Big Beautiful Bill Act, the official name for the long-awaited budget reconciliation bill. The bill makes certain changes to Medicaid to generate long-term savings, namely by adding work requirements starting no later than the end of 2026 for Medicaid recipients who are able-bodied adults without children. Many policies that would have been more harmful for Kansas hospitals, like site-neutral payments in Medicare, changing the federal Medical Assistance percentage rate for Medicaid and reduced percentage caps on provider taxes, were not included.

However, the bill attempts to limit future increases in provider tax rates and state-directed payments. What "future increases" means dominated the vast majority of our interactions with Congress during the past month. For provider taxes, we were able to clarify that the bill's language of grandfathering in rates already "imposed" included Kansas' recently passed increase to six percent. However, the original bill said that state-directed payment rates would not be subject to a Medicare-rate cap only if they had been "approved" by the Centers for Medicare & Medicaid Services by the time the bill goes into effect.

This would have left out the bill passed during the 2025 Kansas legislative session that brings Kansas' Critical Access Hospitals and Rural Emergency Hospitals into the provider tax program to receive enhanced support. We worked with Representatives Derek Schmidt and Tracey Mann to address this problem. Their efforts paid off as the House Energy and Commerce Committee changed "approved" to "submitted." While this requires the Kansas Department of Health and Environment to work quickly to submit an updated preprint for 2026 that includes the CAHs and REHs in the provider tax program to CMS before the bill goes into effect, it keeps the window of achieving this open. Many thanks go to Representatives Schmidt and Mann and their offices for their diligent work on our hospitals' behalf!

This revised language, however, still leaves the state in a precarious position. KDHE knows the clock is ticking for them to submit the 2026 preprint and waiver on time, which is a moving target based on how fast Congress can pass and President Donald Trump can sign the One Big Beautiful Bill Act into law. KDHE is working with KHA staff to submit the 20206 pre-print and waiver by June 30. We are now working with our Senators to amend "submitted" to a date certain in the future that would give KDHE enough time to complete its work. Discussions are ongoing, but Senators have been receptive to our request.

While it is too early to tell how the debate will play out in the Senate, it will dominate the month of June on Capitol Hill. There are indications that some deficit hawks may try to bring back discussions on site-neutral payments and hard percentage caps on provider taxes, but at the same time, the chamber's moderates are unhappy with many of the House's Medicaid provisions. Regardless, we believe we've made headway in explaining our positions to our state's Senators. In our meeting with Senator Moran in early May, he discussed the importance of Kansas' provider tax program. As the bill proceeds and goes through the always-unpredictable legislative process, we will continue to press our concerns. <u>Heart of Health Care Award</u> – The award recognizes and honors the excellence of health care workers statewide. Previously, this award was called the Health Care Worker of the Year Award. All nominated employees (one employee from every hospital) will be recognized by KHA for making a significant contribution to the betterment of their hospital.

<u>Trustee of the Year Award</u> – The award recognizes and honors a hospital board member from each facility who is a leader, gives back to the community and routinely goes beyond the call of duty. KHA members are encouraged to recognize a trustee who has served with distinction and made significant contributions to the betterment of their hospital and community.

<u>Workforce Strategies Award</u> – The award recognizes a team of employees, providers or volunteers who worked collaboratively to make a significant contribution to the well-being, retention, or recruitment of health care workers at their facility(s) or in Kansas.

<u>Charles S. Billings Award</u> – The award recognizes a hospital leader for his or her lifetime of service and continuing contribution to the health care of Kansas. This is the top honor given by KHA. This award was established in 1971 to honor KHA's first president, Charles. S. Billings' dedication and years of service to Kansans.

<u>Donald A. Wilson Visionary Award</u> – The award recognizes hospital-related individuals who have made outstanding, innovative contributions to health care delivery, health care financing or initiatives that improve the health and clinical outcomes of their community. This award was established in 2007 to honor long-time KHA president and CEO Donald A. Wilson's dedication and years of service to Kansans.

<u>Distinguished Health Care Advocate Award</u> – The award honors individuals, organizations or groups that have demonstrated their commitment to health care through participation in the public domain. This award allows members of KHA to recognize those who work on our behalf from outside our ranks.

The Centers for Medicare & Medicaid Services has communicated that the Clinical Laboratory Improvement Amendments is going paperless for email notifications, electronic fee coupons and CLIA certificates. Labs need to initiate the switch, and the deadline is March 1, 2026. KHA Discharge Data Expanded Payer Code Lunch & Learn – June 18

In January, to advance the hospital data collection and improve analytics, the Kansas Hospital Association launched the <u>expansion of payer code categories</u> used in the discharge data program to better identify insurance coverage for all hospital discharges submitted to our data partner, HIDI – the Hospital Industry Data Institute. The goal is to have all KHA hospitals successfully using the expanded codes by July discharge submissions (due Sept. 15). This new information will support our hospitals, KHA advocacy opportunities and population health initiatives.

KHA and HIDI will host an *Expanded Payer Code Lunch & Learn* from noon to 1:00 p.m. on Wednesday, June 18. During the session, participants can ask questions regarding the required modifications to established data submission processes.

CMS Releases Request for Information about Price Transparency

The <u>Centers for Medicare & Medicaid Services requested information</u> about improving prescription drug price transparency, new guidance about hospital price transparency and an <u>updated</u> price transparency resources <u>website</u>. These actions will "strengthen two key regulatory actions," <u>transparency in coverage</u> final regulations and the <u>hospital price</u> transparency final regulations.

CMS also <u>released</u> a request for information about how to identify challenges and improve compliance and enforcement processes related to the transparent reporting of complete, accurate and meaningful pricing data by hospitals. Comments about the prescription drug price transparency request for information will be due 30 days following publication in the *Federal Register*, and comments about the hospital price transparency request for information will be due by 10:59 p.m. Monday, July 21.
