President's Perspective - Navigating 340B in Challenging Times

Protecting the 340B Program remains a top priority for the Kansas Hospital Association. We continue to engage in activities focused on 340B advocacy, including an event last week with health care leaders from across the region. KHA collaborated with the state hospital associations in Missouri, Arkansas and Oklahoma, along with APS, to host a Regional 340B Roundtable on June 12 in Springfield. Approximately 120 health care leaders attended the event, which was presented by SunRx. More than 20 Kansas hospital leaders participated.

The Regional 340B Roundtable featured several national experts who provided insights and perspectives on 340B compliance, as well as state and federal legislative and regulatory issues, along with program updates. Jason Prokopik, senior manager and pharmacy consultant at Blue and Company, shared key insights with attendees on best practices to ensure compliance and enhance the effectiveness of the 340B program. Ted Slafsky, publisher and CEO of the *340B Report*, presented highlights of activities at the state legislative and regulatory levels. Currently, 19 states have enacted 340B protections, with Oregon and Vermont being the most recent. Jeff Davis, partner at Bass, Berry and Sims, informed attendees about litigation concerning 340B rebate models and provided his perspective on policy considerations at the federal level, including the expected Health Resources and Services Administration's guidance on a 340B rebate model and the administration's proposal to shift oversight of the 340B program to the Centers for Medicare & Medicaid Services.

Leaders from each of the hosting hospital associations shared state-level initiatives and ongoing strategies regarding 340B protections and enforcement. The day concluded with panel presenters who discussed case studies and best practices for administering effective and compliant programs.

KHA's next focus area will be 340B Lunch and Learns for elected officials. These events, hosted in partnership with the Community Care Network of Kansas and the Kansas Pharmacists Association, will educate legislators on the critical importance of 340B in sustaining health care access in Kansas. They are scheduled to take place later this summer and fall, with the first event set for Aug. 21 in Salina. We hope you will join us during these events.

IT Workforce Funding Available

Does your hospital have IT team members who could benefit from upskilling? Or are you looking to hire new IT staff who may need foundational training? Two registered apprenticeship programs, <u>Customer Service Tech Support</u> and <u>IT Generalist</u>, are now available to Kansas health care employers at no cost for the next three years.

Each program consists of 150 hours of flexible coursework to prepare workers for vital IT roles. Through Kansas' health care apprenticeship intermediary, TalentGro, hospitals can access these programs and related support services at no cost.

As a reminder, these opportunities are made possible through dedicated funding from the Kansas Apprenticeship Act, which supports hospitals in "apprenticing" up to 20 employees per EIN per year for advancement training and covers the costs of intermediary assistance.

AIM OB Emergency Readiness Learning Series Begins June 25

The <u>Alliance for Innovation on Maternal Health</u> is hosting a five-part series focused on obstetric readiness for emergency medical services and emergency departments in rural communities. It aspires to identify opportunities for collaboration between EMS, hospital EDs and local support networks. The series includes recommendations tailored specifically for rural EMS and EDs, featuring innovative strategies such as telehealth and mobile care units. Register to attend any or all of the sessions. Each lasts 75 minutes via Zoom, scheduled from June 25 to Aug. 13. In the first session, experts will summarize the challenges of obstetric care in rural communities and highlight community resources available to support pregnant and postpartum patients. This series is hosted by AIM with funding administered by HRSA's Maternal and Child Health Bureau. It builds on previous HRSA-funded initiatives created by AIM, including the <u>AIM Obstetric Emergency Readiness Resource Kit</u>.

DocuSign Phishing Email Campaign

The American Hospital Association advises that it has received credible field reports regarding an ongoing phishing email campaign utilizing the legitimate DocuSign email infrastructure. Reports indicate that these phishing emails have been sent to various healthcare entities. The email appears to originate from a state-level Department of Public Health and requests a signature on a document. Please check the sending address in the email, as it does not end with the usual ".gov" domain.

The FBI has requested that if anyone in your organization receives a DocuSign email with the described phishing scheme, please forward the email as an attachment from your organization, or send the message directly to the FBI at mp cyberintake@fbi.gov.

- The American Medical Association <u>offers</u> a series of podcasts aimed at enhancing provider confidence regarding patients and cannabis use. Podcast episodes discuss crucial topics such as preventing cannabis use among minors, cannabis and pain management, cannabis use during pregnancy, related psychiatric disorders, and other significant issues.
- U.S. drug deaths among young people are rapidly <u>declining</u>, according to provisional data from the Centers for Disease Control and Prevention. The latest available records show that fentanyl and other drugs killed more than 31,000 individuals under the age of 35 in 2021. By last year, that number had plummeted to approximately 16,690 fatal overdoses, CDC data reveal.
