

# KHA's Current Report August 15, 2025

President's Perspective – KHA Distinguished Health Care Advocate – Rep. Derek Schmidt
The Kansas Hospital Association Distinguished Health Care Advocate Award honors those individuals, organizations or groups who provide an exemplary contribution to the health and well-being of the people of Kansas through their leadership in public, political or policy areas. This award provides KHA members the opportunity to recognize those who work on our behalf from outside our ranks. At any level of the public spectrum, these award recipients are unique, and their outstanding commitment to the health of Kansas is extraordinary, including this year's honoree, Rep. Derek Schmidt from Kansas's Second Congressional District.

Rep. Schmidt's commitment to health care advocacy spans more than two decades. Rep. Schmidt was Senate Majority Leader in the Kansas Legislature, where he consistently championed health care issues affecting Kansas communities. His understanding of how policy connects to access and outcomes has been a hallmark of his leadership. He is regarded as a pragmatic, solutions-oriented policymaker who values the role of hospitals in rural and urban communities alike.

Subsequent to his role as Senate Majority Leader, Rep. Schmidt was elected as Kansas Attorney General. During this time, Rep. Schmidt played a key role in several health care policies, notably the successful recovery of dollars through opioid lawsuits, which led to the establishment of the Kansas Fights Addiction Grant Review Board. Rep. Schmidt also collaborated with KHA to create an online toolkit to increase awareness within the health care community on human trafficking. Further, Rep. Schmidt was a staunch supporter of hospitals participating in the 340B Drug Pricing Program, defending the ability to stretch scarce resources and serve vulnerable patients. In that role, he regularly engaged with hospital leadership to understand their operational and legal needs, and he worked to ensure federal and state laws were interpreted and enforced in a way that protected care access.

At the national level, now as a member of Congress, Rep. Schmidt continues to support policies that ensure Kansas hospitals remain stable, sustainable and equipped to care for their communities. His actions during the budget reconciliation negotiations underscored he is willing to step up — even unexpectedly — to advocate for what's right for Kansas. Despite not serving on a health-related committee, Rep. Schmidt took the initiative to fully understand a critical Medicaid financing issue that would have harmed Kansas hospitals and patients under the proposed federal Budget Reconciliation bill. His leadership and personal advocacy led to the inclusion of a manager's amendment that improved the policy language and protected the financial integrity of the Kansas Medicaid program — a result that surprised and deeply impressed health care leaders across the state. He and his staff approached the issue not from a political angle, but from a "what's best for Kansas hospitals" perspective. That kind of relationship-building is rare — and deeply valued.

Whether in the legislature's Attorney General's Office or the halls of Congress, Rep. Schmidt has shown his support for health care is not tied to headlines or election cycles, but to a long-standing belief in the critical role hospitals and providers play in community well-being. He consistently shows up, listens to health care leaders and acts on their behalf — even when it's not politically required. His actions have contributed to the financial sustainability of Kansas hospitals, increased access to services and protected care for vulnerable Kansans across the state.

On behalf of the KHA membership, I would like to congratulate Rep. Derek Schmidt as the 2025 KHA Distinguished Health Care Advocate! He will be recognized, along with other health care advocates and leaders, at the <a href="KHA Convention and Trade Show">KHA Convention and Trade Show</a> Sept. 4-5, in Wichita.

#### **Provider Assessment Update**

On Monday, Aug. 11, the Kansas Department of Health and Environment submitted the response to the latest round of questions on the 2025 provider assessment preprint to the Centers for Medicare & Medicaid Services. CMS had clarified their instructions about trending forward the Medicaid base payments, which required a recalculation of the payment information for the preprint. The recalculation resulted in a shifting of funds between inpatient and outpatient enhancement pools, which means that the 2025 Q1 payment calculation will need to be updated. That recalculation, as well as the collection of the 2025 Q2 data and reconciliation of payment for calendar year 2024, are currently in process.

CMS also sent a list of questions for the 2026 preprint, which was submitted on June 30, 2025, to meet the grandfathering requirements of HR 1 (One Big Beautiful Bill Act). This has required KDHE to pull additional data for our contractors at HMA to update the calculations for 2026 as well. Updates on the anticipated impact of 2026 will be provided as soon as they are available. KHA continues to work with our delegation to expedite the final decision on 2025. ## Warning About Narcan Effectiveness in "Purple" Fentanyl

Our partners at the Kansas City Regional Fusion Center shared, <u>'Purple' Fentanyl Found in Omaha</u>, from the Omaha Police Department, about a new type of street drug referred to as 'purple' fentanyl. The Omaha report states it originated from the Kansas City area, so it may be seen in Kansas hospitals. An additional concern is that this fentanyl is mixed with lidocaine. The lidocaine intensifies the side effects of the fentanyl, but since it isn't an opioid, Narcan does not reverse its effects. Share with your clinical teams as needed.

## Agency for Healthcare Research and Safety Program for HAI Prevention

The Agency for Healthcare Research and Quality Safety Program for Healthcare-Associated Infection Prevention, led by NORC at the University of Chicago and Johns Hopkins University, is now recruiting hospitals for its next Catheter-Associated Urinary Tract Infection cohort. Eligible hospitals must have adult ICUs and non-ICUs, at least 50 total beds and five beds per unit.

Scheduled to begin in February 2026, this free, nine-month program provides participating units with technical assistance, expert coaching, interactive webinars and practical tools to strengthen infection prevention efforts. Continuing education credits are available at no cost.

AHRQ will host a series of informational webinars. Dates, times and registration links are posted online.

### FDA Requires Major Changes to Opioid Pain Medication Labeling

Last week, the Food and Drug Administration <u>announced</u> the agency is requiring safety labeling changes for all opioid pain medications. The labeling changes follow a May <u>public advisory</u> <u>meeting</u> and are intended to explain and emphasize the risks associated with long-term use of opioids. The labeling changes are extensive and include clearer risk information, stronger warnings about higher doses, clarified use limits, treatment guidance and many more. For the full list, see the <u>FDA announcement</u>. The FDA gave manufacturers thirty days to submit their labeling updates to the FDA for review.

#### **August is National Immunization Awareness Month**

National Immunization Awareness Month highlights the importance of routine vaccines to protect people of all ages from vaccine-preventable diseases. Trusted resources your facility can rely on for factual information to stay updated and help answer questions from your patients include: Immunize Kansas Coalition, of which KHA is a member, American Academy of Pediatrics, Kansas Academy of Family Physicians, American Medical Association and Voices for Vaccines. Be Immune Kansas, developed in partnership with the Kansas Chapter of the AAP and KAFP, is also a trusted source and includes a toolkit for health care professionals.

Additionally, KDHE's Immunization Coverage Data provides current immunization data for kindergarten-age children, as well as influenza vaccine data. KDHE's Measles Data Dashboard shows there have been a total of 90 measles cases across 12 Southwest and South Central Kansas counties so far in 2025. Measles, mumps and rubella vaccination rates in Kansas kindergarteners have declined from 94.47 percent in the 2019 – 2020 academic year to 90.12 percent in the 2023 – 2024 academic year. According to the AAP, the community immunity threshold for measles (the percent of the population needed to be immune to measles through vaccination or previous infection) is 92-94 percent.
