# President's Perspective – Mission Accomplished: Board and Convention Take-Aways

Last week was the Kansas Hospital Association's 2025 Annual Convention and Trade Show in Wichita. KHA's 2025 Annual Convention and Trade Show was last week in Wichita. The event brought together nearly 1,150 attendees statewide and was filled with excitement, education and excellent networking. The convention theme was *Mission: Possible*. And based on the feedback we received from attendees, I would describe the event as a *Mission: Accomplished*. I want to reiterate my appreciation to the KHA Convention Planning Committee for their guidance, the entire KHA staff for their hard work and KHA's Hayley Finch-Genschorck for her outstanding leadership. Everyone worked together to ensure this year's convention was a success. Thank you to all attendees, trade show exhibitors and sponsors.

Before the convention kick-off, the KHA Board of Directors met in person to discuss several emerging and pertinent topics, including the latest information on the Rural Health Transformation Program. The KHA team provided background information regarding the RHTP, as well as the results of the KHA-initiated member survey to obtain recommendations and priorities. In addition, the KHA Board reviewed and adopted a series of guiding principles to assist KHA as ideas and recommendations are presented. The document *KHA Principles for a Sustainable Kansas Health Delivery System* is online. More information on the RHTP, including information shared during our Sept. 9 member webinar, is available online. Kansas Department of Health and Environment Secretary Janet Stanek joined last week's KHA Board meeting and our member webinar to share additional information on the RHTP and to gather feedback. It is anticipated the Centers for Medicare and Medicaid Services will be releasing the formal application in the near future. In addition, more information is expected to be provided by Governor Laura Kelly's office as additional guidance is made available.

- Welcomed Sandy Dickerson, administrator and CEO, Greenwood County Hospital, Eureka as a new director of the KHA Board
- Appointed Sarah Teaff, CEO, Patterson Health Center, Anthony, to fulfill a vacant position on the KHA Board of Directors
- Approved the KHA associate membership applications for Beeler Consulting and Amergis Healthcare Staffing
- Reviewed the KHA Governance Committee's recommendations for the slate of directors that was presented to the KHA membership during the annual meeting

- Adopted the KHA finance and investment report
- Highlighted the KHA state and federal advocacy efforts for the remainder of 2025
- Discussed the workforce strategies recommendations that were developed during the KHA Board retreat
- Reviewed the 2025-2027 KHA Strategic Plan dashboard and recent KHA initiatives
- Presented the latest initiatives surrounding health care finance and reimbursement, including a study on the area wage index
- Provided a status update on the fundraising progress of KHA's Political Advocacy Committee.

#### **2025 Provider Tax Preprint Approval**

Kansas Hospital Association staff are pleased to share we were notified late Tuesday, Sept. 9, that the 2025 provider tax preprint, which allows the state to draw down federal matching funds to match the provider tax at six percent, was approved!

As with any significant achievement, it took a team to reach this goal. Our congressional delegation, led by Senator Moran and his team, played a crucial role in the negotiations on HR 1 this summer, which maintained the viability of the 2025 provider tax plan and kept it moving forward in the approval process. At the state level, Governor Laura Kelly, the Kansas Department of Health and Environment leadership and the Medicaid finance team went above and beyond in working with KHA to ensure timely responses to CMS requests; thereby, keeping the 2025 provider tax changes moving forward in D.C. It is valued partnerships like these that will help Kansas hospitals achieve our vision of optimal health for Kansans and Kansas hospitals.

Last week, KHA sent an update to each of the hospitals with their 2025 Q1 Medicaid quarterly enhancement payment amount, based on the six percent tax rate. In that update, we provided a timeline that would begin once approval was received from CMS. Here is the updated timeline:

- The week of Sept. 8, KDHE will submit the request to the state treasurer to transfer the funds from the HCAIP account to the Medicaid managed care organization for distribution to the hospitals and send the payment amounts to the managed care organizations.
- The week of Sept. 15, the funds will be transferred to the MCOs on Thursday and should arrive in their bank accounts on Friday, Sept. 19.
- Beginning the week of Sept. 22, the MCOs will distribute the funds to the individual hospitals within the next two weeks.

Please note: This will be the first time Healthy Blue distributes the Medicaid quarterly enhancement payments. Please let us know if you have not received a distribution from Healthy Blue by Oct. 1, and we will assist you in tracking down the funds.

The tax payment that was due to the state on May 30, 2025, but was delayed pending approval of the 2025 waiver and preprint, will now be due on Oct. 31, 2025. Please note, this does not apply to CAH and REH hospitals, which will not begin paying the tax until May 2026, pending CMS approval.

# **Broadband Informational Webinar – Sept. 16**

The <u>Federal Funding Group</u> and the Health-e Broadband Consortium are hosting an informational webinar on Sept. 16. <u>Healthworks</u> created the <u>consortium</u> to enable members to access subsidies collectively and to negotiate contracts with the Federal Funding Group. FFG is a consulting firm based in Evergreen, Colorado, with deep expertise in the Healthcare Connect Fund and is a valuable asset in providing services to its members. Join us to learn more about the eligibility of sites and services. Information will be shared regarding timelines for the 2025 funding window and any program changes. Below are a few key highlights of the program:

- The HCF provides a 65 percent discount on broadband services and equipment.
- A consortium may receive a funding commitment for a period of three years. Individual applicants must be approved annually.
- Additional funds may become available for costs, such as construction, that are not accessible to individual applicants.
- Urban hospitals are allowed to access the 65 percent discount if they are a part of the consortium. They are not able to access the discounts as an individual applicant.

As a member of the consortium, our goal is to help hospitals maximize their savings while enhancing services at their facilities. This webinar will be a step toward achieving this goal!

#### **Conditions of Participation and Interpretive Guidance Communication**

With the rapid rate of change in Conditions of Participation and the resulting Interpretive Guidance for surveyors, it is challenging to keep pace for you and those responsible for survey readiness and compliance. To keep up with communications from the Centers for Medicare & Medicaid Services, go to Policy & Memos to States and CMS Locations on the CMS website. This is where CMS releases and archives Quality, Safety and Oversight memoranda, guidance, clarifications and instructions to State Survey Agencies and CMS locations. The site provides information and guidance on the Conditions of Participation for all hospital types, as well as nursing facilities and CLIA-regulated clinicians.

For example, on Sept. 5, they released <u>QSO-25-24-Hospitals</u> to provide revisions to the State Operations Manual – Appendix A for PPS hospitals. CMS states, "This will accomplish two objectives: The first is to issue new interpretive guidance and survey processes for Conditions of Participation (CoPs) that were finalized and established in 2019 and 2020. The publication of this guidance was delayed due to COVID-19 public health priorities. The second portion of this update is to incorporate previously issued guidance from QSO memos S&C-16-29, 19-13 (revised), QSO-20-04, 22-20, 23-09, and QSO-23-19 into the SOM."

## **HRSA Accepting Applications for State Loan Repayment Program**

The Health Resources and Services Administration is currently <u>accepting applications</u> for the State Loan Repayment Program, which provides cost-sharing grants to states to operate their own loan repayment programs for primary care providers to serve in Health Professional Shortage Areas.

In return for serving in these underserved communities, providers receive loan repayment awards. The application period runs through Jan. 12, 2026.

#### Before You Go ...

- The National Alliance on Mental Illness recognizes September as <u>Suicide Prevention</u>
   <u>Month</u> and created <u>this toolkit</u> for partners and advocates to help raise awareness about this urgent issue. By talking openly about suicide prevention, recognizing warning signs and encouraging help, NAMI hopes to spread hope and spark meaningful action.
- September is <u>National Recovery Month</u>, an annual observance initiated by the Substance Abuse and Mental Health Services Administration designed to increase awareness, reduce stigma and celebrate the successes of those who have embarked on the journey of recovery.
- A 2025 <u>study</u> published in the *Journal of the American College of Surgeons* found that
  patients who develop alcohol withdrawal during hospitalization are twice as likely to
  experience respiratory failure and face a 61 percent higher risk of sepsis. The findings
  underscore the importance of awareness, clinical consideration and improved screening
  to help prevent poor outcomes after surgery.
