President's Perspective – KHA Wraps Up 340B Lunch and Learns

This week, the Kansas Hospital Association, along with our partners at the Community Care Network of Kansas and the Kansas Pharmacists Association, wrapped up the 340B Lunch and Learn series. These educational events convened policymakers, pharmacists, clinics and hospitals to provide education on the importance of the 340B Program to health care access in Kansas.

More than 91 Kansas hospitals are covered entities in the 340B Program. The program enables covered entities to purchase medications at a discount and use those savings to stretch scarce federal resources. Hospitals, in turn, can provide more patients with comprehensive benefits. 340B Lunch and Learn events took place on Aug. 21 in Salina, Sept. 18 in Olathe and Sept. 23 in Wichita.

The health care leaders who attended the 340B Lunch and Learns provided examples to the dozens of elected officials in attendance on how the program provides discounted medications to their patients and supports medically necessary services in their communities. I want to thank all our members who participated in these informative events.

As we educated policymakers this week about the benefits of the 340B program, we learned some Kansas legislators were receiving text messages claiming hospitals were misusing the program. This is on top of the recent *Wall Street Journal* editorial claiming "rich hospitals have been gaming a discount drug program for the poor." In response to this misleading editorial, the American Hospital Association has submitted a response on behalf of all hospitals. This is a good reminder for members to contact their elected officials and discuss the value of the 340B program in your community.

To assist the membership in communicating the importance of the 340B program, KHA has developed a 340B toolkit. If you or your team have not reviewed the toolkit recently, please explore the many customizable resources available. We encourage members to add hospital logos and utilize the template social media posts. KHA will continue our statewide 340B communication campaign, but it is more impactful if members supplement these efforts by sharing with your community and policymakers just how important the 340B program is to your community. You can also link to or share our public-facing website, www.340BKansas.org, which features member testimonies on the importance of the 340B program. Process Announced for the Rural Health Transformation Program

Yesterday, Governor Laura Kelly announced the state is taking steps to develop an application for the \$50 billion Rural Health Transformation Program. The RHTP is intended to infuse millions of dollars into states' health care systems and to bolster rural communities by improving access to and the quality of care available to Kansans. Of the \$50 billion RHTP, \$25 billion will be distributed evenly to states whose applications are approved. The other half will be dispersed based on factors outlined by the Centers for Medicare & Medicaid Services in the application released on Sept. 15, 2025. Kansas must submit one application for this funding by Nov. 5, 2025. CMS will then announce the funding awards by Dec. 31, 2025. The funding will be distributed over the next five years. More about the Rural Health Transformation Program can be found on CMS.gov.

Governor Kelly is establishing the Kansas Rural Health Innovation Alliance to convene a group of stakeholders who will oversee the development of the application and the implementation of the initiatives outlined in Kansas' plan. The state, in association with the University of Kansas Health System Care Collaborative, will present an educational webinar at 9:00 a.m. on Monday, Sept. 29, 2025, to further outline the application and stakeholder engagement process.

We encourage our members to <u>register online</u> for this educational webinar, in which they will learn more about the proposal requirements outlined by CMS, as well as the next steps for the Kansas submission.

Hospitals are broadening their approach to infection prevention by moving beyond central line-associated bloodstream infections to include all vascular access devices. Catheter-Associated Bloodstream Infections, part of the larger Hospital-Onset Bacteremia and Fungemia framework, offer a pathway to strengthen patient safety, improve quality measures and reduce costs from preventable infections. This webinar will feature a hospital case study that expands surveillance to include peripheral IV catheters and central lines. The broader monitoring approach led to more targeted interventions, lower infection rates and stronger alignment with evolving quality reporting requirements.

ACOG Affirms Acetaminophen Safety During Pregnancy

This week, the American College of Obstetricians and Gynecologists issued a <u>statement</u> affirming the safety of acetaminophen use during pregnancy. ACOG emphasized the more than two decades of research on the use of acetaminophen during pregnancy and cited two high-quality studies, including one published in <u>JAMA</u> last year, that found no significant associations between use of acetaminophen during pregnancy and children's risk of autism, ADHD or intellectual disability.

Kansas Fights Addiction Statewide Needs Assessment Available

Sunflower Foundation has released the comprehensive, statewide needs <u>assessment</u> of substance use disorder systems. The needs assessment was funded by the Kansas Fights Addiction Board and conducted by the University of Kansas Center for Public Partnerships and Research. The assessment aimed to gain a better understanding of SUD system needs in Kansas to further reduce substance abuse and addiction, save lives and improve systems of care. CMS Issues Contract Year 2026 Medicare Advantage Disclosure Final Rule

The Centers for Medicare & Medicaid Services released the <u>final rule</u> for contract year 2026 Medicare Advantage disclosure. The rule requires Medicare Advantage plans to increase beneficiary access to provider data while comparing plans in the CMS Medicare Plan Finder tool. *MLN Connects* Weekly Newsletter Articles:
