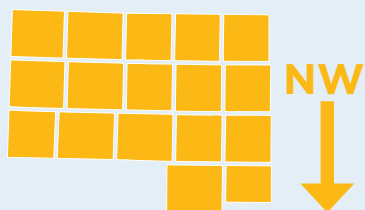

340B savings are critical to Kansas hospitals providing access to care and creating healthier Kansas communities.

pharmacies:**  
**\$9.8 million**

Losses due to pharmaceutical manufacturer restrictions for 340B hospitals in the NW District since 2019 are estimated at **\$4.8 million.**

## NORTH CENTRAL DISTRICT

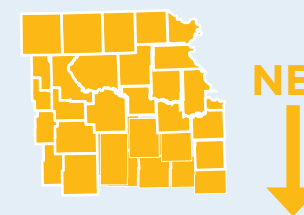

**\$731 million**

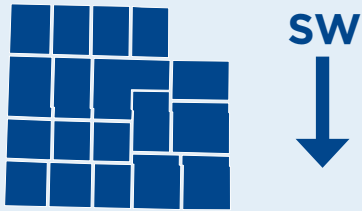
**2023 NE 340B savings via contract

Losses due to pharmaceutical manufacturer restrictions for 340B hospitals in the NE District since 2019 are estimated at **\$14 million.**

**Pharmacy closures since 2015: 46**



**Why are pharmacy closures important? Through 340B, local pharmacies provide discounted medications closer to home. Pharmaceutical manufacturers' contract pharmacy limitations harm patients, pharmacies and local communities.**

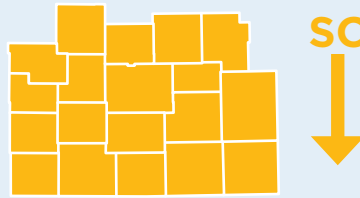

Losses due to pharmaceutical manufacturer restrictions for 340B hospitals in the SW District since 2019 are estimated at **\$4.6 million.**

## SOUTH CENTRAL DISTRICT

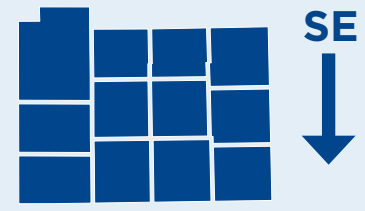

Losses due to pharmaceutical manufacturer restrictions for 340B hospitals in the SC District since 2019 are estimated at **\$5.7 million.**

## SOUTHEAST DISTRICT

**2023 uncompensated care SE District:**  
**\$59 million**

**2023 SE 340B savings via contract pharmacies:**  
**\$4.7 million**

Losses due to pharmaceutical manufacturer restrictions for 340B hospitals in the SE District since 2019 are estimated at **\$4 million.**

**Pharmacy closures since 2015: 12**

## Keeping Kansas Communities Healthy



Hospitals in Kansas provided **\$1.1 BILLION** in uncompensated care in fiscal year 2023.



In 2023, Kansas 340B hospitals reported 340B savings of **\$103 MILLION.**

**Key takeaway: Hospitals provide essential uncompensated care in Kansas. Pharmaceutical companies mischaracterize the benefits hospitals receive from the 340B Program. Kansas hospitals depend on the 340B savings to continue to provide health care services to ALL Kansans.**
