## *Safeguarding Innovation with Responsible Guidelines*

### June 12 Pre-Work for AI Policy

AI policy is crucial because it provides a necessary framework to manage risks, ensure ethical and safe deployment and foster trust in rapidly evolving environments. By setting clear rules, AI policies protect organizations from data breaches, legal penalties and unintended bias while guiding staff on acceptable use. This session will cover key AI concepts and terminology, examples of AI use in health care settings and issues that should be addressed in AI policies. It will also establish a foundation for the second webinar by introducing AI policy structure and outlining the key decisions organizations will need to make throughout the development process. The session will be interactive and will actively solicit input from participants.

### June 30 Building Ethical AI Policies

Building on the foundation established in Workshop #1, this interactive session takes a comprehensive, section-by-section look at the core components of an AI policy. Presenters will walk participants through each component in depth, examining how to frame key sections, draft meaningful provisions and ensure policy addresses the issues most relevant to your organization. The session will also provide an overview of strategies for policy rollout, navigating change management, implementation and ongoing monitoring needed that keeps your policy current as AI evolves.

Registrants will be provided with access to a handout to use throughout the training, serving as a practical resource to support the development of an AI policy.

### Speakers

This webinar series is led by the Kansas Health Institute team, which has delivered AI capacity-building workshops in collaboration with the Wichita State University Community Engagement Institute, led technical assistance engagements, developed an AI Policy Template and Guidance resource featured on the CDC's AI website to support organizations in crafting their own policies. KHI conducts policy and research work across several AI areas, including rural invisibility in AI algorithms, environmental impacts of AI and AI policy tracking.
