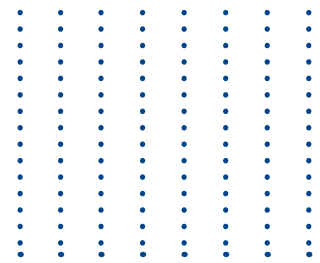

Medication errors remain one of the most common preventable sources of patient harm in hospital settings. Oversight and support for safe medication use is a critical aspect of overall patient safety. Medication safety is a cornerstone of multiple regulatory and accreditation bodies, as well as quality performance programs. An understanding of top medication safety issues as well as prevention strategies are important topics for hospital and health system associates.

This two-part webinar series brings together pharmacy and clinical leaders from across Kansas to explore both the “what” and the “how” of medication safety. Participants will gain insight into the most frequently reported medication safety risks in hospitals today, hear real-world perspectives from health system, community, and critical access settings, and learn actionable strategies aligned with Institute for Safe Medication Practices (ISMP) guidance.
